The meeting was called to order by Chris Szverra at 7:03.

Special Guest Laila Jones, Community Engagement Officer from AA County Executive's Office.

Old Business:

- 1. VOMCA Treasurers Report:
 - a. Checking \$1363.25
 - b. Savings: \$1,591.57
- 2. Swim Club Treasurers Report:
 - a. Checking: \$4,310.18
 - b. Savings: \$523.53
 - c. 15 members: 4 Active, 11 Inactive.
- 3. VOMCA Membership Report: Currently have 36 paid members for 2021.
- 4. Laila Jones: County Updates:
 - a. COVID Update: Vaccines each week fluctuate based on the amount the county gets from the State Health Dept.
 - b. Impacted Workers Grant: ACDSINC.org to apply.
- 5. Minutes: Discussion, Review and Acceptance: Reviewed and passed unanimously
- NCEON Food Drive Update: Still going on. Chris Szverra received got a letter thanking us for our donations (180 bags in 2020)
- Food Pantry at Park: The Food Pantry is being put to good use. We are requesting anyone that is able to help us keep an eye on it and keep it stocked for those in need.
- Mews at Millersville: Still no updates. Last we checked there wasn't a final decision on approval.
- Traffic at Wade's Grant: County Budget meeting was last night. Traffic circle was brought up and does have some support at the county level for funding.
- 10. Update on American Pool and Others
 - As of now, Paul Schaffer is coordinating with Ace Aquatics regarding a contract for this season.
 - b. American Pools stated they would not roll the previously owned debts into the future contracts.
- 11. Pool Loan Update: Chris Szverra went to the bank on February 3 with all the paperwork. The loan approval is going through process. The offer from the bank, instead of a loan, would be a \$25,000 line of credit. The Pool Committee will plan to hold a meeting as soon as we have more information.
- 12. Crier Advertising Rate Change: \$25 full-page, \$18 half-page, \$10 quarter-page, with a 20% discount for annual.
- Membership Drive: We need new members to join VOMCA. Specifically, we need people that are willing to get
 out and help with the various community projects throughout the year.
- Fundraisers: We are planning a fundraiser through Panera Bread. VOMCA would receive 20% of the proceeds from the fundraiser.
- 15. Mulch Sale Update: We've sold 91 bags so far. The sale is still ongoing.
- 16. Barlowe Bolt Update: As of Feb 4 we have 21 people registered for the Bolt.
- Mikaela's Silver Girl Scout Award Project Update: We are still on for putting a Lending Library in the vicinity of Barlowe Field

New Business:

- Easter Egg Hunt Discussion: Egg Hunt still planned for April 3rd.
- Barlowe Bolt Sponsorship: If you know of anyone that would want to sponsor the Barlowe Bolt, have them contact Randal Stites or Chris Szverra.


FOOM March Updates

It is still early in the year, but a lot is going on. We kick off our outdoor time this year with our Community Day on Saturday March 6, 7am to 1pm at Barlowe Field, preparing gardens for the year and making the area beautiful for our Barlowe Bolt on Saturday morning March 27th, run starts at 7am and this is our biggest fundraiser of the year, run, or just volunteer to help out (running it is less work). Aside from general garden cleanup we are going to focus on the Memorial Garden at the park entrance, we want to create a brand-new shape for it and expand it a bit. To do this, we need to simplify the plant layout and mixture in the garden, so we are calling for all gardeners with a shovel to come by and dig up the entire garden freeing up the 1.5 million plants currently in it. Anyone who helps can take some home, and what is left unplanted will probably be available at our Flea Market on Saturday May 22, 8am to 11am, at a very reasonable price. Any money raised or donations given will go toward the new, simple, easy to maintain yet colorful plant layout that will not obscure the memorials that are, and will be, located there. We have enough to do at our park that you or your group can social distance and work on a specific area or planter, masks are required.

Also, do not forget we are signing up volunteers to assist with the **installation of the new playground** items during the month of April. Sign up to help on 4/10-11, we will be clearing and leveling the install area, or 4/17-18, the actual install weekend of the new equipment, a little cement, a lot of wrench turning, and then on 4/24-25 we hope to finish it up with some new mulch and detail work, maybe a little painting. if God, the weather, and you volunteers all cooperate we hope to open it Saturday, May 1st. Please see the news from Allison Pickard's office below, in it you will find these comments related to COVID restrictions in Anne Arundel County

"Organized sports – for Indoor Facilities, there is no longer a limit on participants and coaches in an activity area. Indoor facilities must still maintain a total occupancy less than 50% of the facility's maximum capacity and masks must be worn at all times except for participants on the field of play. Contact tracing provisions are recommended but no longer required.

All Outdoor Sporting Venues - Total allowed occupancy is increased to the lesser of 250 persons or 50% of maximum capacity."

"Organized outdoor events with designated event organizers are now permitted with no more than 100 persons."

This is the news we were waiting on as it positively impacts our events in the next several months including the Barlowe Bolt, Flea Market, Spring Fling, and the entire pool season (we hope the swim team league will decide to have a normal season this year).

We have been watching the swim memberships come in and believe many are currently inactive because people are waiting to see what happens, is there a swim team season, will we be open normally this summer, etc., by spreading this news we may be able to positively impact our events and fund raising and active pool memberships that are so important to bring in the funds that allow us to do what we do.

Mosquito Control Section

Season 2021

Dear Community Association Officer or Representative:

Your community has requested to participate in the adult mosquito surveillance and control program offered by the Maryland Department of Agriculture, Mosquito Control Section. This letter contains the enrollment form and important program information for the season. If you are no longer the representative for your community, please forward this to the appropriated individual or contact us immediately.

Routes will be filled on a first come, first serve basis. Forms received once the route in that community's area is full or after the deadline will be retained and your community will have the opportunity to apply to participate in our program the following year.

Please be advised that this application is for adult mosquito control service only, an application is not necessary for larval control, inspections and complaint investigations.

Program information can be found on the enclosed sheet entitled Standard Mosquito Control Operating Procedures. More specific information including an assigned spray night of the week will be forwarded after applications have been returned. It is the responsibility of the city/town or community association to make available to all residents information regarding mosquito control activities, policies and spray schedules. A record of the method of notification must be maintained for a year and made available immediately upon request by the Department. In order to keep our records up to date, please include a new map if there are any changes to your community's requested spray areas. See the attached directions for details on how to create an effective map.

Residents who wish their properties to be excluded from adult mosquito control services must notify the Maryland Department of Agriculture and the community association by submitting a completed exemption form. The Departments policy on objection to adult mosquito control services and the exemption form are enclosed and are available on our website at:

mda.maryland.gov/plants-pests/Documents/NewExemption%202016-1.pdf

Please note that ULV spray treatment of adult tiger mosquitoes is most effective when conducted in conjunction with community cleanup efforts. The effective way to control mosquitoes in your neighborhood is at the community level. We encourage home owners and communities to be proactive in their efforts to control mosquitoes by becoming aware of backyard breeding sites.

Due to the number of participating communities, e-mail is the suggested method of contact, however e-mail access is not required. If you have any further questions or concerns, or would like us to meet with you and your community members, please feel free to call or e-mail me. For additional information on mosquitoes, mosquito-borne diseases, insecticides, and tips to reduce mosquito breeding areas in your yard please visit our website; http://mda.maryland.gov/plants-pests/Pages/mosquito-control.aspx


