Get Your Soil Tested Before Planting

Before you fertilize your yard this fall or even purchase flowers, shrubs, or trees, have your soil tested to determine what kind of soil you have and therefore what kind of amendments the ground might need. At the end of July, I will have soil testing kits with simple instructions that I can drop off at your house, or that can be picked up at mine. Return them to me before August 21 with a \$10 check (or cash) made out to University of Delaware.

Anne Arundel Watershed Stewards Academy, of which I am a steward, will send the soil samples to the University of Delaware. In mid-September, a Bay Friendly lawn care workshop will be presented—most likely at Arlington Echo—with a University of Delaware Soil Scientist to discuss Maryland's new fertil-

izing regulations and the results of the soil tests. You do not have to attend the workshop to receive your results but the workshop is free. Contact Stacy Epperson at 410-987-7533 or (better) by email at tryswim@comcast.net for questions or to request a kit. —Stacy Epperson
