### Armored Truck Robbery at 7-Eleven

On August 8, 2012, at approximately 11:45 a.m., officers from the Eastern District responded to a report of a robbery of an armored car employee at the 7-Eleven store located in the 400 block of Old Mill Road in Millersville.

Preliminary investigation reveals that an employee of Loomis was servicing the ATM machine located inside the aforementioned 7-Eleven store when he was approached from behind by the suspect. The suspect implied that he had a weapon and took the employee's satchel containing an undetermined amount of U.S. currency. The suspect then fled the store on foot and was last seen fleeing the area in a gray-colored vehicle. A thorough search of the area was conducted by responding officers and detectives, but the suspect was not located. (Continued from page 2) That is what 'clean your stream one yard and one street at a time" means.

Before you add your fall fertilizer (or spring), are you sure it needs it? How green does your yard need to be and why? Have you ever spent the \$20 to have your soil tested? It is better to know how much if any your soil needs before you place unneeded fertilizer on the yard that will flush out with the first rain into the nearest storm drain. The decision to have your soil tested is a small one. The decision to not fertilize this year is a small one. The decision to sweep your street curb is a small one. The decision to scoop your pet waste more frequently is a small one. The decision to plant native plants (acclimated to our climate and therefore may not need soil amendments) instead of the non-native generic plants is a small decision. Are your neighbors doing these things? No? Set the example. Talk about what you do. Another small decision. Watch it spread. Clean your stream, one yard and one street at a time.

### County Executive Leopold Urges Residents to Apply for Homestead Tax Credit

Annapolis (August 8, 2012) - County Executive John R. Leopold today urged residents to make sure they are signed up for an important property tax credit before a critical deadline passes.

The Maryland Department of Assessments and Taxation has set a deadline to apply for the Homestead Tax Credit by the end of this calendar year, County Executive Leopold said. People who do not sign up could have to pay hundreds or even thousands of dollars more in property taxes next year. Many people are unfamiliar with this program because their taxes are paid by a mortgage company, but it is very important to pay attention to this.

It is very simple to determine if you are approved for the Maryland Homestead Tax Credit. Go to the State database at <a href="http://sdatcert3.resiusa.org/rp\_rewrite/">http://sdatcert3.resiusa.org/rp\_rewrite/</a> and type in your address. At the bottom of the page, check the field that says Homestead Application Status to see if you are approved.

If you are approved, there is nothing you need to do. If you are not approved, you can apply online by going to <a href="https://sdathtc.resiusa.org/homestead/">https://sdathtc.resiusa.org/homestead/</a>. Be sure to have a copy of your most recent assessment notice handy to fill out your information.

The Homestead Tax Credit protects homeowners from sudden and sometimes dramatic increases in property tax bills from reassessments. Once a homeowner is eligible for the credit, his or her property tax can increase by no more than 2 percent in a given tax year.

The deadline to apply is December 31, 2012. There is no way to appeal your bill once the deadline has passed. You can contact the Maryland Department of Assessment and Taxation directly at 410-974-5709.

### Barlowe Field and Playground Are Community Assets, Need Community Help

The playground at Barlowe Field is owned by the community of Olde Mill. It is for the enjoyment of all and therefore the maintenance of the structures, the sandbox, and the basketball courts are the responsibility of all the residents of Olde Mill.

Since we are *not* a homeowners association with very high membership fees for living in these developments, we depend on the volunteer payments of our \$15 per year community dues and pool income to pay the taxes and maintain the field areas. The softball field is maintained by the Olde Mill softball league while the field itself is mowed by the community and paid for by the proceeds from the swim club and the community association. The playground mulching of the areas under the swings and the play structure were paid for by donations and fundraisers in the past held by FOOM (Friends Of Olde Mill). This was a special group organized as a Non-Profit 503(c)1 to give a tax break to those donating money and for purchasing equipment and mulch without paying tax. With donations dwindling and a seeming lack of interest in volunteer help, FOOM is no longer in existence.

The current structure and baby swings are about 10 years old. The mulch and ground cover currently on the ground under these structures is about 5 years old. Replacement of structures runs over \$10,000 today, while a recent estimate for just mulch amounted to \$1,500, with weeding and mulch \$2,500 and sand for the sandbox at \$100 if we purchase from the same vendor. The current play structures cost about \$8,000 10 years ago.

Vandals have tried to vandalize the play structure, older children have swung on the baby swings and one of the leather seats of the baby swing was cut with a knife. The original swing set has been repaired but with constant swinging the sand has worn away and left deep holes under the swings.

Money, volunteers and donations would be appreciated in helping to get our playground back to a condition that everyone could enjoy. Unfortunately, out of 1,300 families, we have less than 100 members who have joined the association. With an income of \$1,500 from the community, we are not able to do any major renovations or replacements. We need support from the community, which has seemed to dwindle as the years have passed, to keep our community a place to be proud of.

The volunteers who are part of the community association and who put countless hours into the upkeep of the pool and just maintaining the playground have done this job for 10 years or more. Time moves on and without new faces and new energy, these tasks may not continue to be done. With 1,300 families in this development, it is unfair to expect that a few people year after year take on the responsibility of an entire neighborhood with many hours of work without pay or support from others.

Elections are in October. Please step up and volunteer to run for an office, help with weeding the playground, or assist with the many jobs necessary to the operation of the pool. Contact <a href="mailto:board@vomca.org">board@vomca.org</a> if you are interested or have any suggestions.
