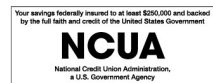

My husband grabbed his phone and dialed 911. Unfortunately, the person must have seen the light of my husband's cell and shut his/her light off. My husband ran and turned on the back floodlights and when he opened the back French doors to the backyard saw the person running, medium build wearing a hooded sweatshirt. We have a privacy fence so I am not sure if they went through the back garage door and out the front or hurdled the door. The police came and a report was taken.

Then on October 25, as I was running at 6:00 a.m., I saw a police car circle our cul-de-sac. I made a left onto Chalet and then a left on Ahearn. About 5 houses down there were police cars and people outside a garage with flashlights. I stopped to ask and they said that someone had broken into their garage. The person was on a bike and a mobile crime unit was there taking prints. The person took some copper but that was all.

When our incident took place I went to every house on our street and told them. Later that morning, as I continued my run I stopped and informed every person leaving for work, walking the dog, etc. that I saw. I am thinking of posting notices at the stop signs in the neighborhood as well.
