Current membership in VOMCA is about 120 families. This is less than 10 percent of the families who live in Olde Mill. With more members participating in the financial health of this community, we would be able to do more things. Homeowner associations charge hundreds of dollars to live in their communities but they also can provide more services with that money. Only \$15 to live in Olde Mill is an unbelievably small amount to pay for any comparable community, voluntarily.
