We need to increase membership in the Swim Club and in the community association in order to remain a viable community and operate as we have in the past. Participation and payment of membership dues by everyone who lives in the community is vital to maintaining our ability to function as an association in order to acquire state or county services such as sidewalk repairs.

Joining the Swim Club provides the money to pay the bills necessary to maintaining and staffing the pool for the summer, which costs an average of \$90,000 per season. The budget is published in December or January each year.
