We also thank Mike Hakulin, Jr., for his years of service to FOOM and for his past leadership and accomplishments at Barlowe Field over time.

With the community's support of FOOM fundraising efforts toward renovating the playground, we hope to create an area that will serve Olde Mill's children for years to come. We need to increase membership in the Swim Club and in the community association in order to remain a viable community and to operate as we have in the past. Participation and payment of membership dues by everyone who lives in the community is vital to maintaining our ability to function as an association in order to acquire state or county services such as sidewalk repairs.

Joining the Swim Club provides the money to pay the bills necessary for maintaining and staffing the pool for the summer, which costs an average of \$90,000 per season. The budget is published in *The Village Crier* in December and/or January.
