Minutes of September 3 Meeting

The meeting was called to order by Sarah Hakulin, President of VOMCA and Pool Director. Management issues were on the agenda and a new management company was invited to discuss a proposal for managing our pool next year.

Matt Helfrich from Continental Pools went over information about the company and answered questions on their proposed contract. He stated that we did not have to sign up for a 3-year contract with an option to renew but we could try his company for 1 year instead. He spent time answering all questions and concerns. Contract proposal was \$43,650.00 for one year. New proposal with changes were sent next day in a very timely fashion.

(*Note: The above estimates for all proposals that were requested ran roughly eleven thousand dollars less than the previous Community Pools contract that concluded this season at \$54,100 for the year.)

It was suggested that the pool gate cash box be reconciled every week. It was agreed that \$20 will be used

as a bank when pool opens for guest fees.

It was discussed keeping a copy of pool membership forms to have email addresses from them to send out pool news and info via email. A space for email addresses with a choice of allowing such usage or not will be included in the membership application.

A motion was made and unanimously passed to start accepting credit cards for pool membership. More information to come.

As of 8/31/14, the Swim Club savings has \$12,047.18; checking has \$31,664.84.

There was discussion about getting one more proposal from American Pools, and that a decision on who to go with be made prior to October 1.

The pool companies contacted were DRD, Continential, American, and Community Pools.
