President's Message

THINK WARM...THINK POOL...LOOK FOR YOUR POOL PACKET COMING SOON!

Thanks to everyone who came to the February 4th meeting. We had 21 members show up to hear a representative, Chris Casey, from the County Executive's Constituent Service Office give a presentation on how Special Tax Districts work for communities like ours who do not have enough voluntary dues participation from residents to afford improvements and repairs to their pools, playgrounds, landscaping, and other needed amenities. (96 families out of 1300 in Olde Mill have joined.)

After the presentation, a vote was taken and all of those present voted to proceed with plans to change Olde Mill into a Special Tax District.* It is a long procedure requiring homeowners to vote on it and a lot of work, but with the support of everyone, the effort will be amazingly beneficial at its completion. We need 51% cooperation for this plan to be implemented. Additional information and questions can be directed to board@vomca.org We would become part of the 90 community organizations in Anne Arundel County that have already adopted this way of paying their dues for services and repairs in their communities.

The Eastern District of the county police department has reached out to us to attend a future meeting to discuss any crime or traffic problems that are causing residents concern. We will try to schedule a speaker for our meeting in April. Check the next *Crier* for further information.

On March 28th VOMCA and FOOM are again sponsoring the free Easter Egg Hunt for children at Barlowe Field at 1 p.m. If you can donate any wrapped candy sized to fit in plastic Easter Eggs, please contact Sarah Hakulin at oldemill 2@aol.com. Raffles and prizes will be part of the festivities.

General Meeting Minutes

The meeting was called to order on Wednesday, February 4th at 7:05 p.m. by President Sarah Hakulin. A quorum was present (20 members).

Concerns:

The pool has a major crack in 1st stairwell at the water line and the baby pool has pump inside which is frozen, and needs removal. The Treasurer is setting up credit cards for pool access. It was agreed that solar panel will be considered for the pool.

Activities:

The Barlowe Bolt will take place on 3/21/15. Register at www.active.com. Early bird registration is \$25.00 and after March 1st, it is \$35.00. This will be a 5K or 1 miles fun run / walk. Sponsor applications and registration information can be found on www.facebook.com/BarloweBolt or www.facebook.com/TheVillageofOldeMill. This is tax deductible for participants and benefits the playground.

This year's Easter Egg Hunt is March 28th. We are seeking candy donations to fit into the plastic eggs. Please call 410-987-1239 to donate. This is tax deductible and benefits the playground.

Speaker for the special tax district discussion:

Mr. Chris Casey, Constituent Service Office. The purpose for this is to petition funds for special projects or services for the community that would not otherwise be received. The money would be collected from each property owner in the community in lieu yearly dues. These special items could include special security or police protection, insect and pest control, maintenance of private roads, improvement to community facilities. The Board would designate a uniform special tax rate per tax account to accommodate this special tax district. A petition for approval of the community would be circulated to the community after approval by the county's Office of Budget. At least 51% approval by the community must be received to be considered. Cycle begins in October and ends January 31st to be submitted to the County. The special tax cannot take on debt. This special tax is considered property tax and is tax deductible. It is done on an annual basis. The county takes a 5% admin fee. The state can randomly audit the funds and once every 4 years the audit is mandatory.

A vote was taken and all 21members present voted to pursue the steps necessary to become a "Special Tax District". There are 90 such districts in AACO such as The Provinces, Southgate, and Crofton.

Villas Added to Planned Zeman Subdivision

Below is a letter from the engineers who are developing the Zeman subdivision adjoining Olde Mill's property lines. There were some changes to the previously submitted plans which added 18 additional units in the form of "villas" and reduced the number of single family homes.

As reported last summer, the Zeman/Neidert property which abuts the south side of Olde Mill is slated for development in the near future. (See the August 2014 Crier for the article about Zeman Assemblage.) The original site plan called for 98 townhouses and 99 single-family homes, to be accessed from Obrecht Rd. The developer has modified that plan to change some of the single-family units to semi-attached villas. A pre-submission community meeting was held at Heritage Community Church in Severn on February 9, 2015, to explain the details. Approximately 17 people attended the meeting, along with the developer and the engineer's representatives. The following summary of the presentation was sent to nearby property owners from the Messick Group, which is doing consulting engineering for the subdivision developer Elm Street Development:

Jim Krapf, the Project Manager and Vice President with Elm Street Development, opened the meeting by explaining that Elm Street Development is a land development company that has been developing land in Anne Arundel County for the past 30 years. Elm Street is the contract purchaser of the properties. The reason for the meeting is to inform the community of any changes that have been taken place during the final plan process. This is a requirement of the county code.

We are currently in the final plan process. The site plan is actually the same since we had our last community meeting in August of 2014, with the exception of a few changes to the building product in the central area of the site, where a villa product is now being proposed. A villa product is a semi-attached, 2 story dwelling with an optional first floor master bedroom. The villa is a smaller product than a single-family home and is being proposed in response to market demand for a different type of product. A total of 46 villas are shown on this plan. The number of new single family homes has decreased from 99 to 71. A total of 18 more units will be added by incorporating the villa product.

Regarding the timing of this project, we plan to submit the revised Final Plans in approximately 1-2 weeks from now. We are hoping to get final plan approval in approximately 6 months, with the project starting (development work) in about 12 months from now.

The floor was then opened for questions and the following questions and answers were given:

Q–In the northeast corner of the plan where the townhouses are showing, has that changed? *A*–No, it has always been planned as townhouses. The villas are proposed in the central area of the site, which is the only thing that has changed since the last meeting.

Q–*Are the villas a lower priced product?*

A–No. They will be 2-story, 2-car garage, 30-35 feet wide like the product present in the development at Shipley's Crossing near the round-about on Brightview Drive.

Q–Was a traffic study done?

A-It was and the villa product reduces the number of trips compared to the single family homes that were replaced.

Q-What about the road widening? Any changes?

A–It has stayed the same as previously proposed.

Q–Will there be 71 villas?

A–No, 46 villas and 71 single family homes are currently planned.

Q–Have you had a naturalist review and walk the property?

A-No, we have not. The site plan will now have a lesser impact on the forested area you are talking about.

Q-Does the longer street come out onto Obrecht Road?

A-No. The primary access is existing Zeman Drive and the 2nd access is located about 1000 feet to the east of Zeman Drive.

The meeting adjourned at approximately 6:30 p.m. Several attendees stayed following the meeting and spoke to Mr. Krapf individually.


