#### Airport Noise Committee/BWI Noise Coalition

#### December 31, 2017

The Airport Noise Committee for the Greater Severna Park Council and the BWI Noise Coalition has learned that last November, the FAA filed a statement in the Federal Register, seeking comments from the general public about a proposal for FAA to create a new 'Noise Portal'. This would enable the FAA to receive noise complaints directly instead of piecing the information together from multiple sources.

Neither the FAA or MAA made that information easily available to the public. As a result, we are now running out of time. The comment period ends in two days. (01/02/2018)

Please fill out a formal comment to the FAA on the Federal Register site at this link. Let them know if you agree with the FAA's intention to request the Office of Management and Budget's (OMB) approval for a voluntary information collection.

You can comment on any aspect of this information collection, including (a) whether the proposed collection of information is necessary for FAA's performance; (b) the accuracy of the estimated burden; (c) ways for FAA to enhance the quality, utility and clarity of the information collection; and (d) ways that the burden could be minimized without reducing the quality of the collected information. The agency will summarize and/or include your comments in the request for OMB's clearance of this information collection.

Thank you for your participation. Together we can be louder than BWI.
