

MEMORANDUM

TO:	Homeowner Groups and Community Advocates
FROM:	Steve Schuh Stand
DATE:	January 26, 2018

I wanted to inform homeowners groups and community advocates of new County legislation that strengthen our efforts to implement the principles of smart growth and preserve our rural land by directing development into areas with adequate infrastructure.

Right now, our team at the Office of Planning and Zoning is engaging the public through listening sessions to assist in developing the 2019 General Development Plan. This document will map out land use in our County for the next decade.

As we undertake this process, we hear frequently from citizens who are grappling with changing communities and increased congestion. We hear their concerns and are committed to addressing them. The next five years will be crucial as we look to preserve our citizens' quality of life through a balance of measured, responsible development and land preservation.


That is why I was so excited this week to sign Bill 92-17, which will limit development for communities in school clusters if a school is at 95 percent capacity or above. Prior to this legislation, residential development was already closed in the following school feeder systems and clusters: Annapolis. Arundel, North County, Old Mill, and South River High schools due to schools being at capacity.

As a result of Bill 92-17, the Northeast High School feeder will be closed to residential development, ensuring the Pasadena area will join these other areas in obtaining needed relief from residential development. In addition, families who send their children to Oak Hill Elementary School in the Severna Park feeder will also enjoy the same relief.

This legislation will help provide a much needed pause as we work to draft the General Development Plan for our County, and I look forward to working with every citizen as we work to reduce congestion and preserve our quality of life. Friday, April 27th!


