VOMCA Meeting Minutes:

The August VOMCA meeting was called to order on Wed. Aug. 1, by Pres. Bev Parker. There was a quorum so business could be conducted.

American Pools Manager, Shawn gave this update: There have been positive comments from Guests and no major issues this summer. The pool is in need of some essential repair:

Proposals-

- * Replace 2 Light Ring Adapters \$465.32 around pool
- * Pool ladders need commercial grade-plastic treads replaced (aprox \$1000)
- * Whole pool repair is Aprox \$136,000. Price could go up once repairs begin. Needs to be done sooner rather than later. Can be broken down to separate repairs, but cost would be more expensive separately. Whitecoat (resurfacing pool) is the #1 priority at approximately \$24,000.

American Pools is looking into loan and payment options.

US Pools also submitted an estimate for Whitecoat at \$28,000 with other costs to be determined.

GGBSoccer has been in arrears with payment for use of Barlowe Field for 2017. Coach Charles Musgrove was not in attendance to give his side of the issue. (\$700)

Soccer has a history of late payments for several years. They think the field rental cost is too high. Softball pays the same amount.

Issue was tabled since Coach Musgrove was not at the meeting.

New FOOM President, Randal Stites, proposed removal of 2 trees on memorial site on Barlowe Field that are infested with bagworms. Top Notch Tree business, owner Ryan Thompson offered to remove dead trees for free and a new evergreen planted by FOOM in its place.

Request was made that residents and groups using the fields not dump in the woods or behind field backstops.

Water issues:

Barb Mason and Kristen spoke on significant flooding in their yards and basements. Some of this is due to the new Pondview housing project going up behind their homes. The County has been contacted.

Meeting adjourned at 8PM.

Too Loud, Too Low, Too Frequent

S.1405 - Federal Aviation Administration Reauthorization Act of 2017

The FAA implementation of NextGen has caused irreparable harm and suffering to people living under the super highways it has created. The relief they are looking for is outlined in several amendments the Senate Transportation Committee is considering right now. They empower the American public by adding protections, improving communication, developing better technologies, and encouraging changes that are compatible with the people.

Unfortunately, the airline industry is fighting very hard to have those amendments thrown out. Senator Thune, Chairman of the Transportation Committee, needs to hear from YOU today! Please contact him to let him know you want the noise to stop and the Cardin/Van Hollen amendment added to Senate Bill S.1405.

Additional Information on the Cardin/Van Hollen Amendments

All 4 noise amendments are attached along with some additional background/summary for three of them. The Committee is still currently reviewing these and does not have any definitive information as to if any will be accepted.

- Van Hollen/Cardin Amendment 1: **21st Century Noise Measuring:**
 - a. Requires the Administrator to adopt and implement a 21st century noise measuring system which employs state of the art technologies, metrics, and methodologies to measure noise experiences in communities affected by the implementation of Next Gen.
 - b. Requires the Administrator to make the data collected as a result of the implementation of the noise measurement system be made publically available and be updated twice a year.
 - c. Requires the GAO to conduct a study within 4 years of enactment on implementation of the 21st century noise measuring system and the extent to which the FAA is using the data in the design and implementation of any flight path changes beginning 3 years after enactment.

- Van Hollen/Cardin Amendment 2: **Cumulative Impacts Amendment:** This amendment would require noise impacts to be calculated on a cumulative rather than per-flight basis.

These first two were offered in the House during their deliberations but were not made in order.

- Cardin/Van Hollen **Airport Noise Mitigation:** this amendment is most of noise title in the House passed bill with a few omissions (not relevant to noise) and with an addition of Baltimore to a list of regions for the FAA to implement a study on the health impacts of overflight noise.

- Cardin/Van Hollen **Noise Dispersion: this amendment is what the Quiet Skies/BWI Roundtable agreed that they want.** The Amendment states that it shall be the purpose and policy of the Administrator to ensure that it protects the safety of aircraft and efficiency of air operations for the benefit of passengers and crew, while also protecting the public from overflights noise and other detrimental effects. To comply with this purpose and policy, the Administrator shall take the following actions:
 - a. Requires the restoration of dispersion over residential areas to levels prior to implementation of Next Gen.
 - b. Requires the FAA to ensure that all aircraft maintain an altitude no lower than necessary for safety.
 - c. Study the feasibility and cost for implementing a Ground Based Augmentation System (GBAS) for the purposes of enhancing safety and achieving dispersion and increases in aircraft altitude. (Ground-Based Augmentation System (GBAS) is a system that provides differential corrections and integrity monitoring of Global Navigation Satellite Systems (GNSS). GBAS provides navigation and precision approach service in the vicinity of the host airport (approximately a 23 nautical mile radius.)

d. Requires a progress report within one year of enactment and an implementation report within two years of enactment on the requirements listed above and on single event noise level comparisons.

THUD Appropriations, for reference:

- *Noise and Community Outreach.*—The Committee appreciates additional measures the FAA is taking to enhance outreach to communities affected by new flightpaths; however the Committee believes the FAA should do more to be responsive to community concerns. The Committee directs the FAA to improve the development of flight procedures in ways that will give fair consideration to public comment and reduce noise through procedure modification and dispersion to reduce the impact on local communities. The FAA should utilize state-of-the-art technologies, metrics, and methodologies to measure actual noise at ground level experienced in communities affected by flight paths and not rely solely on computer modeling or other theoretical measures. The FAA should give high priority to evaluating where increased noise levels disrupts homes and businesses, and threatens public health, and should provide all necessary resources to regional offices to work with local communities to meet this objective.
- *Noise Health Effects:* The bill includes your requested language word for word: *Noise Health Effects Research.*—The Committee supports research that is being conducted through the FAA’s Center of Excellence for Alternative Jet Fuel and Environment, the Aviation Sustainability Center (ASCENT) on the impact of aviation noise on both sleep and cardiovascular health. The Committee directs FAA to continue to prioritize this research, as many communities across the country contend with an increased frequency of passing aircraft on a daily basis. In addition, the Committee directs the FAA to continue to evaluate alternative metrics to the current Day Night Level (DNL) 65 standard and other methods to address community airplane noise concerns, including cumulative noise impacts from increased frequency of flights.
