APRIL MEETING MINUTES

APRIL 3, 2019

The meeting was called to order at 7:06 pm. In attendance were Chris Szverra, President; Reese Szverra, Secretary; Mackenzie Simmons, member; Lisa England, member; Paul Shaffer, member; Nancy Stracke, member; Sandra Sacra, Membership Specialist; Sarah Hakulin, member; Mary Stites, member; Randal Stites, Vice President; Veronica Hilton, member; Chris Hilton, Treasurer; Rick Haynesworth.

The Treasurer's report showed \$2722.24 in the checking account and \$1589.12 in the savings account. The Pool Treasurer's report showed \$23,827.60 in checking and \$35,116.57 in savings.

The pool membership as of April 3: 20 active members and 13 inactive.

VOMCA memberships were 55 households.

Chris Szverra made a motion to accept the minutes from the March meeting as they were in the March Crier. Lisa seconded. The minutes passed with one correction: Dr. Valle's name is spelled V-A-L-L-E, not Valley.

There was no swim club report at this time.

Mulch sale – We sold 137 bags of mulch and made \$2.40 per bag. Therefore, we made \$328.80 off of the mulch sale tentatively.

The sign on Barlowe Field near Olde Mill Road was painted by Mackenzie and Cody Simmons! Thanks, guys; it looks great!

The Easter Egg Hunt Report – Needs are baked goods, candy, and raffle items, bunny chair, raffle tickets. This will be held on April 13th, at Barlowe Field from 1-3 .

Fundraising was discussed. On 4/7, at Chris Szverra's house, there will be a Tupperware party. This is Sunday at 1pm. We make 40% from the fundraiser book and 20% from sales in the another book. The website/sale will continue until the end of the month. The website is <https://tuppercouple.my.tupperware.com>. Lisa England will be selling at the Easter egg hunt as well and all sales there will go toward our total. This benefits the pool repair fund.

The mulch sale can become annual or bi-annual. There was excitement over this discussion. The money from the sale will go into the pool checking account until the supplier is paid, and then will go into the capital account.



Membership Drive – This is a priority!!! We are looking into a banner for Olde Mill with the logo on it to hang where it's visible. It will cost about \$80. (6' x 2') Chris wants to do this from the President's fund. Reese made a motion to allow this money to be spent. Veronica seconded. It was approved unanimously. The banner will have contact information on it, as well as the website and social media contacts.

We discussed briefly how the neighborhood seems to be separated by Olde Mill Road. We want to correct this problem. We are one neighborhood.

Reese wants pictures sent to her for the Olde Mill website to be updated.

VOMCA shirts are ready to be ordered again. We need 10 to order and get the discount. We have 5 in the order. We are looking to fill the order before we place it.

We briefly discussed where to put signs out so that we could maximize the amount of people who see them.

New Business – Build days are coming up. These are held at the park and are led by Randal. So far, he has made a trench to help with drainage, cleared out the basketball fence and woods of blockages, dug a dirt pile in the pool area and outfield and placed piping there in the first section so that the area now drains well. It's starting to dry out, but we need to rake, lay the rest of the pipe, and spread the dirt. This will stop the mud from building up in the field. No formal walking path will be laid around the field perimeter, however, this will make a mud-free plath for people to walk around the park. Randal needs help to finish the drainage project. At the basketball court, there is a new trash can, no more barrel cans because they are hard to handle. Randal has been checking them. The pergola can take about 2 weeks to fill up, and new bags are available.

The Snack Shack – the external metal needs to be repaired, bathrooms painted and spruced up, and reorganizing the storage area (emptying the attic so that we can store bins up there for events). We need to change the shelving. We need to change the doors to open the shack window. Hopefully, bi-fold doors will go in there. Reese is handling the gardens. They need to be spruced and we will place a plaque to Janet Counts in them. Reese is leading the Beautification Committee.

The proposed work days are 4/27 and 5/11. On 5/18, the pool work will be done by the Swim Team and families.

VOMCA needs to have a table manned at every event that takes place in the community. Workers don't need to be members. We can recruit people in the neighborhood by word of mouth also, and flyer the schools to get kids to come out with their parents. Teens can use this as service work hours as well. We can also flyer CAT North to help.

Chris wants the Olde Mill sign to say, "Home of the Olde Mill Swim Club and the Torpedoes Swim Team".

We are also making a book of the businesses in Olde Mill. We just need to focus on getting more help, more people involved.

Pool Bond, Part II – Paul and Kevin Kendall want to change our proposed new pool membership and bond costs. The cost will remain the same in total; however, the membership will be \$220, and the d will remain at \$400. This is for first time members ONLY. The reason they propose this is because the

price of the bond affects all membership. We want to help out new members to draw them in. The money coming in is the same - \$620 total. However, this will not lower the price of the bond after discussing it some more, the motion to pass this was made by Chris Szverra. Reese seconded. The motion passed at 9 for; 1 against; and 1 abstaining. Paul will let us know how membership is affected as we move forward. (Packets are on the pool gates)

Rick's Pool work list – Sean from American Pools will come out Wednesday, 4/10 to discuss the work involving new coping stones, water line tile and caulking and provide an estimate. In addition, we need to cut and fertilize the grass; power wash the decks; guard stations washed and painted; and diving board painted; etc. The Swim Team work day is May 18, and they will be handling these things. We will send the information to pool members and VOMCA members to recruit help from the neighborhood.

On Next Door, Nancy sends everyone a welcome and tells them Chris' information. She invites them to join VOMCA and gives them meeting information as well. They say they will come, and don't. She suggested a second note to invite them out to the meetings.

Where are we meeting for summer? Church on the Rock is a possibility. Steak and Shake is possible too. Having a FOOM or VOMCA meeting on a fundraiser night could help us to get people from Old Mill schools involved in our groups and it gives us a chance to give out information. We want to make a real effort to join our groups together and to include the schools where all of the children in our neighborhood go to school.

A motion to adjourn the meeting was made by Reese. It was seconded by Chris. We adjourned the meeting at 9:02pm.

Mosquito Control Section

Season 2019-2020

Dear Community Association Officer or Representative:

Your community has requested to participate in the adult mosquito surveillance and control program offered by the Maryland Department of Agriculture, Mosquito Control Section. This letter contains the enrollment form and important program information for the 2019-2020 seasons. If you are no longer the representative for your community, please forward this to the appropriated individual or contact us immediately.

We are only able provide adequate service to approximately ten communities per truck per night. Routes will be filled on a first come, first serve basis.

Applications must be postmarked by **April 12, 2019**. We will not add new communities to our program after this date. Forms received once the route in that community's area is full or after the deadline will be retained and your community will have the opportunity to apply to participate in our program again in two years.

Please be advised that this application is for adult mosquito control service only, an application is not necessary for larval control, inspections and complaint investigations.

Program information can be found on the enclosed sheet entitled **Standard Mosquito Control Operating Procedures**. More specific information including an assigned spray night of the week will be forwarded after applications have been returned. **It is the responsibility of the city/town or community association** to make available to all residents information regarding mosquito control activities, policies and spray schedules. A record of the method of notification must be maintained for a year and made available immediately upon request by the Department. In order to keep our records up to date, please include a new map if there are any changes to your community's requested spray areas. See the attached directions for details on how to create an effective map.

Residents who wish their properties to be excluded from adult mosquito control services must notify the Maryland Department of Agriculture and the community association by submitting a completed exemption form. The Departments policy on objection to adult mosquito control services and the exemption form are enclosed and are available on our website at:

Please note that ULV spray treatment of adult tiger mosquitoes is most effective when conducted in conjunction with community cleanup efforts. The effective way to control mosquitoes in your neighborhood is at the community level. We encourage home owners and communities to be proactive in their efforts to control mosquitoes by becoming aware of backyard breeding sites.

Due to the number of participating communities, e-mail is the suggested method of contact; however e-mail access is not required. If you have any further questions or concerns, or would like us to meet with you and your community members, please feel free to call or e-mail me. For additional information on mosquitoes, mosquito-borne diseases, insecticides, and tips to reduce mosquito breeding areas in your yard please visit our website; http://mda.maryland.gov/plants-pests/Pages/mosquito_control.aspx

OPERATING PROCEDURES FOR SPRAYING OF ADULTICIDES (Treatment for adult mosquitoes):

Regular Surveillance and Control of Adult Mosquitoes: May 29 – October 1

Sunday-Thursday (A night of the week will be assigned to your community)
Anytime between 7:00p.m. - 2:30 a.m.

Spraying for adult mosquitoes will be **done only if a Maryland Department of Agriculture Employee determines it is necessary.**
Spraying **will not be conducted** during rain, in wind speeds exceeding 12 MPH, or temperatures above 89°F.

Thresholds for Ground Based ULV Treatments:

- Landing Counts: 3 mosquitoes in a 2 minute count
- Light Trap Collections: 12 female mosquitoes in an unbaited light trap
24 female mosquitoes in a baited light trap
- Conditions that threaten public health, such as mosquito borne disease

Adulticide	Formulation and application rate
<u>Permanone 30-30:</u>	Liquid
Permethrin mixed with Piperonyl Butoxide and Mineral Oil	0.0031 lbs/acre (Ultra Low Volume application)

The **Mosquito Control Program does not spray for Midges** that swarm on homes, boats, trees and shrubs along many Anne Arundel County creeks and rivers. These non-biting insects develop in mud bottoms of slow moving water ways of low dissolved oxygen and will decline in numbers within a few weeks after they first appear.

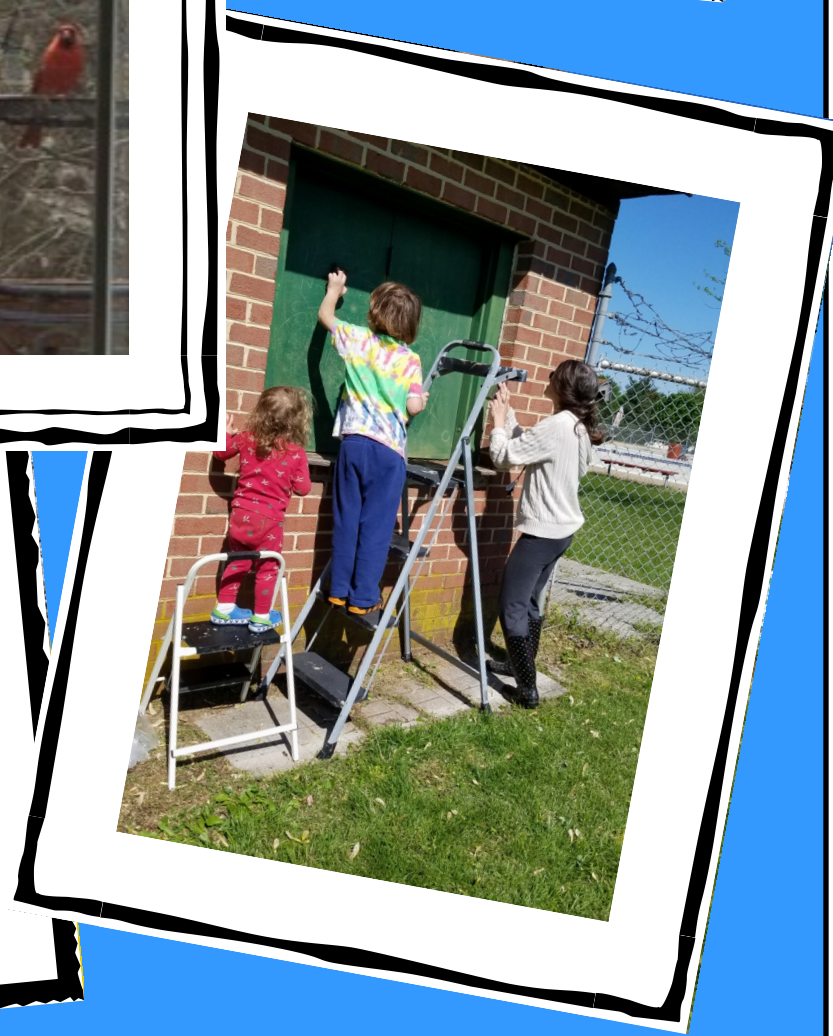
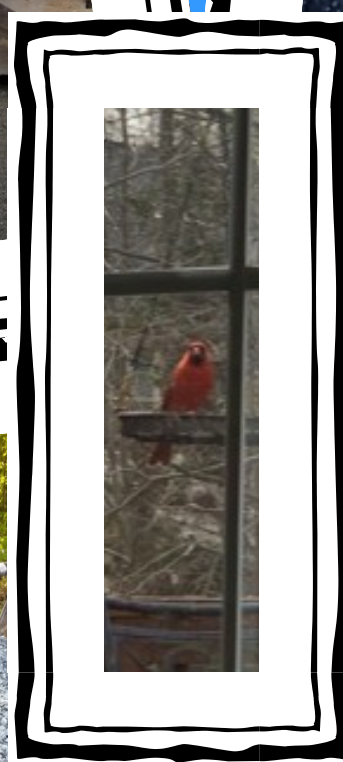

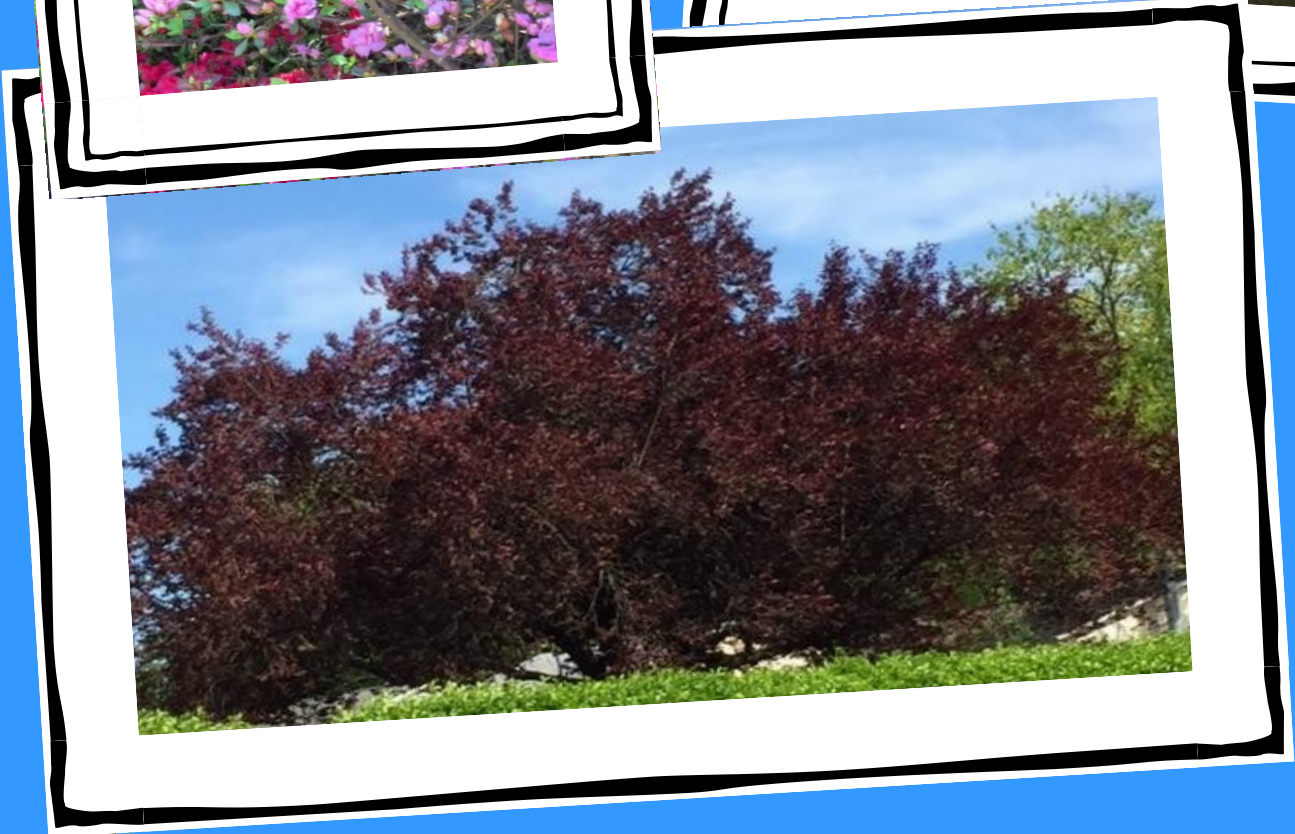
