## Village of Olde Mill Community Association Meeting

Date: December 4, 2019

Location: Old Mill High School, Room A272

The meeting was called to order by Chris Szverra at 7:10. 11 total members 2 visitors presenting a Sports proposal to the assembled group.

### Old Business:

#### Treasurers Report:

Savings: \$1,590.19

Checking: \$1287.25

#### Swim Club Treasurers Report:

Savings: \$246.02

Checking: \$24,411.29

Membership Report: Currently have 64 households in the Association. To date, 16 have paid their dues for 2020.

Minutes from the previous meeting were reviewed and accepted unanimously by members present.

Budgets: 2020 Budgets for VOMCA and OMSC were reviewed and accepted unanimously by members present with discussion regarding small details on the budget (how the "Various VOMCA Events" line item was figured and some changed/added items on the OMSC budget).

Crier, Web Page & Mailing List Overhaul: Moriah Haefner is currently heading up the effort to overhaul and update the VOMCA page, as well as associated organization pages. The Crier distribution list is also being reviewed to ensure that all active members are on the list to receive the Crier via e-mail.

Polar Bear Plunge Report: A total of 17 participants jumped into the newly restored pool for the 1<sup>st</sup> Old Mill Swim Club Polar Bear Plunge. In addition, two fire trucks and an ambulance from nearby stations were on hand to support the event. The event raised \$175, which will go directly to support Olde Mill Swim Team. Plans are already being discussed to repeat the event next year.

FOOM's Quarter Auction Report: The Quarter Auction was a successful event for FOOM fundraising efforts. The event raised approximately \$2,500 (\$2,000 after expenses for the event were taken care of).

Plumbing permit issue at the Snack Shack: Several valves were added within the plumbing of the Snack Shack. We also added an external faucet between the two restrooms which will be modified to use a key instead of a standard valve control. The work has all been inspected by the County and approved for operation.

Shade(s) for the Pool: Proposal was made to replace the existing shade structures at OMSC with new shades. Options discussed were to build either a Pavilion or Portable Garage Structure along one of the fence lines as well as some Shade Sails that the board might be able to procure for low cost.

The members present voted unanimously to approve the purchase of an awning (\$99 + tax) that would be available for future VOMCA events.

Chris and Kristin Steelman were present at the meeting to put forth the proposal of starting up the Millersville Soccer Association (MSA) at Barlowe Field. The program would be a youth soccer program that could, in the future, branch out and become Millersville Sports Association, encompassing T-Ball, Softball and other sports into it. Voting to approve MSA usage/rental of Barlowe Field was tabled pending receipt of written proposal from the Steelmans, which would include plans for insurance, field usage, etc. The Board intends to conduct a vote via email on the proposal so the Steelmans can receive an answer and continue forward with their efforts as necessary, based on submitted proposal.

### New Business:

Fundraisers: the next VOMCA fundraiser will be held at Ledo's Pizza on December 9<sup>th</sup>. A flyer for this fundraiser was sent out with the November Crier.

Future Fundraisers: Several proposed ideas for VOMCA fundraisers were put out. The Board is also looking for any additional ideas the community might have for future fundraisers: Wine & Paint Party, Tupperware Sale, Mulch Sale, are examples.

Next Meeting: The next meeting is scheduled for **January 8, 2020, 7:00 P.M., in room A272 of Old Mill High School**. This is a change from the date posted in the schedule in the November Crier.

The meeting was adjourned at 9:08 P.M.



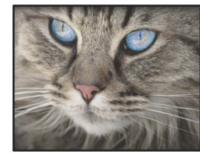

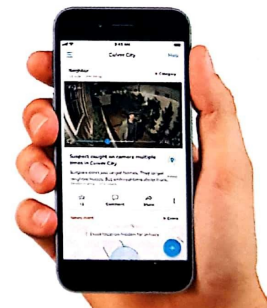
