

VOMCA Treasurers Report: Checking \$352.39 \$100 to NCEON \$200 to Volunteer Fire Department Savings: \$1591.43 Swim Club Treasurers Report: Checking \$4,145.33 Savings \$523.49 164 members: 92 Active, 76 Inactive



VOMCA Membership Report: 76 members at end of year. Cur-

rently have 3 paid members for 2021.

Minutes: Discussion, Review and Acceptance: Reviewed and passed unanimously NCEON Food Drive Update:

Still on-going. Donations can be dropped off at 8263 Mimico North.

The local schools are conducting a coat/mitten drive. Donations can be dropped off at 493 Kenora Drive

Santa will be coming through the community, but no food collection will be happening. With the food drive not happening, we are potentially (awaiting permission) going to conduct a contact-less food collection behind the fire truck with Santa.

Food Pantry at Park: The Food Pantry is being put to good use. We are requesting anyone that is able to help us keep an eye on it and keep it stocked for those in need.

- Tree Lighting Event on December 12: The Tree Lighting Event has been canceled. We are still planning on decorating the tree the day of the event and lighting it around 5:00 PM, but there will not be a formal event.
- MEWS at Millersville: Meeting was one-sided. Inspections and Permits did not show to the meeting; they will be required to show up to future meetings.
- Traffic at Wade's Grant: We are working on getting a traffic circle put in at the intersection.
- Playground Equipment: We had a good turnout of volunteers to disassemble the playground at Loch Haven Park. The playground is currently stored at a storage yard off New Cut Road in Severn until we can get it installed at Barlowe Field in the spring.
- Crier: We are looking for new advertisers for the Crier. Information for advertisements is in the Crier or you can also contact Sarah Hakulin for more information.
- Pool Loan Motion: Motion to authorize Chris Szverra to apply for a loan on behalf of Old Mill Swim Club up to \$25,000 through M&T Bank (our current financial institution) or other banks (as needed) to pay off existing debts and provide additional funds for the start of the 2021 season.

Motion made by Randal Stites; seconded by Lisa England. Vote passed unanimously by quorum.

PACT: CPL McAdoo passed on several general safety/security concerns for the upcoming season.

Loan for OMSC – Update on American Pool:

- Old Mill Swim Club is currently approximately \$12,000 in the red based on the 2020 financial issues (reduced income due to shortened season; increased costs due to COVID concerns).
- We have gotten several proposals for new management companies, most of which are significantly more than American Pools.
- Randal Stites reached out to American Pools. Proposal is to add the current debt owed to American Pools. to the upcoming contract if we go with them for future management.

Police Community Relations Meetings are cancelled until further notice.

Membership Drive: We need new members to join VOMCA. Specifically, we need people that are willing to get out and help with the various community projects throughout the year.
