The meeting was called to order by Chris Szverra at 7:04.

Special Guests:

1. Walt Zawislak: Old Mill Swim Team Representative
2. Cpl McAdoo and Cpl Raiford: AACPD PACT Officers

### Old Business:

1. VOMCA Treasurers Report:
  - a. Checking \$1,707.96 (\$1,050 for Mulch sale for Swim Club)
  - b. Savings: \$1,591.61
2. Swim Club Treasurers Report:
  - a. Checking: \$8,144.50
  - b. Savings: \$523.54
  - c. 30 members: 12 Active, 18 Inactive.
3. Pool Membership Drive: We'd like to get additional memberships from Wades Grant and other surrounding neighborhoods that don't have neighborhood pools.
4. VOMCA Membership Report: Currently have 51 paid members for 2021.
5. Minutes: Discussion, Review and Acceptance: Reviewed and passed unanimously
6. NCEON Food Drive Update: Still going on. Got another letter thanking us and have turned in another 25 boxes of donations since last month.
7. Food Pantry at Park: This is getting a lot of use. If you can help keep it stocked throughout the week, it would be greatly appreciated. Please no perishables or home-made products.
8. Mews at Millersville: Still no updates. Last we checked there wasn't a final decision on approval.
9. Traffic at Wade's Grant: Still working through the process for the traffic circle at Wade's Grant
10. Update on Ace Aquatics: Ace Aquatics will be the management company for OMSC this year.
11. Pool Loan Update: Not approved for a secured loan. We got approved for a \$10,000 line of credit to handle OMSC operating expenses. The pool committee will meet to prioritize the use of the funds.
12. Membership Drive: We are still looking for new members to join VOMCA. We schedule community activities throughout the year. We are planning on keeping meetings through Zoom for the foreseeable future. As conditions improve, we may consider having our meetings at the pool.
13. Fundraisers: No Panera Fundraiser; their fundraisers are only for schools or non-profits. We are looking at other fundraising options.
14. Mulch Sale Update: We have sold 193 bags as of March 3. We have a couple volunteers to help us deliver the mulch.
15. Barlowe Bolt Update: As of March 3, we have 60 registered. With the recent updates to COVID restrictions, we should have no issues holding the event as scheduled.

### New Business:

1. Old Mill Swim Team: Coaches have been named and there is a published schedule for this year's season. Planning 2 Youth nights during the season and an adult event.
2. AACPD PACT Update: Cpl McAdoo and Cpl Raiford gave updates regarding the crime statistics for our neighborhood. Anonymous Tip Line: 410-222-3502 (recording for AA County Eastern District).
3. OMSC Business Credit Card: Motion to apply to M&T Bank for an OMSC Business Credit Card with a \$5,000 limit to be used in conjunction with our current line of credit. We are looking into being approved for a \$5,000 business credit. Chris Szverra made motion; Randal Stites seconded. No interest for the first year. Authorized users on the card would be limited to Paul Shaffer and Chris Szverra. Vote on the measure was 7-6 in favor of the motion.
4. OMSC Insurance Update: R&G will no longer be insuring us for the pool through Nationwide. We are looking at insuring the pool through Western World Insurance. We will look into trying to bundle all of the insurance through Western World.
5. Easter Egg Hunt Planning: Event planned for April 3rd. The eggs will only have tickets within certain eggs for prizes, and we will plan to distribute snack/candy bags (pre-bagged items). We are working photo opportunities with an Easter Bunny as well. We are looking for volunteers as well as raffle items.
6. Playground Plans (FOOM): Randal is working through planning to get the new playground equipment installed at Barlowe Field. Additional adjustments will need to be made to the existing swings to reach required depth.
7. Gardens (FOOM): The memorial garden is going to need a lot of work to get it back into good shape. We are looking at removing existing plants and changing the elevation of the garden to allow better drainage and easier maintenance.
8. Snack Shack Planning: We would like to have the Snack Shack operational during the upcoming pool season. This would help as an additional source of income to support the pool operation.

Meeting adjourned at 9:24 pm. Next meeting will be April 7, 7 pm, via Zoom Cloud Meetings. Link for the meeting is available through the Events link on the VOMCA webpage.

## Mosquito Control Section

Season 2021

Dear Community Association Officer or Representative:

Your community has requested to participate in the adult mosquito surveillance and control program offered by the Maryland Department of Agriculture, Mosquito Control Section. This letter contains the enrollment form and important program information for the season. If you are no longer the representative for your community, please forward this to the appropriated individual or contact us immediately.

**Routes will be filled on a first come, first serve basis.** Forms received once the route in that community's area is full or after the deadline will be retained and your community will have the opportunity to apply to participate in our program the following year.

Please be advised that this application is for adult mosquito control service only, an application is not necessary for larval control, inspections and complaint investigations.

Program information can be found on the enclosed sheet entitled **Standard Mosquito Control Operating Procedures**. More specific information including an assigned spray night of the week will be forwarded after applications have been returned. It is the responsibility of the city/town or community association to make available to all residents information regarding mosquito control activities, policies and spray schedules. A record of the method of notification must be maintained for a year and made available immediately upon request by the Department. In order to keep our records up to date, please include a new map if there are any changes to your community's requested spray areas. See the attached directions for details on how to create an effective map.

Residents who wish their properties to be excluded from adult mosquito control services must notify the Maryland Department of Agriculture and the community association by submitting a completed exemption form. The Departments policy on objection to adult mosquito control services and the exemption form are enclosed and are available on our website at:

Please note that ULV spray treatment of adult tiger mosquitoes is most effective when conducted in conjunction with community cleanup efforts. The effective way to control mosquitoes in your neighborhood is at the community level. We encourage home owners and communities to be proactive in their efforts to control mosquitoes by becoming aware of backyard breeding sites.

Due to the number of participating communities, e-mail is the suggested method of contact; however e-mail access is not required. If you have any further questions or concerns, or would like us to meet with you and your community members, please feel free to call or e-mail me. 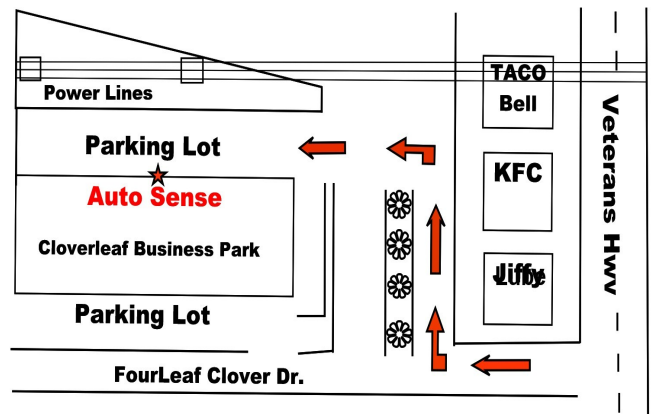
